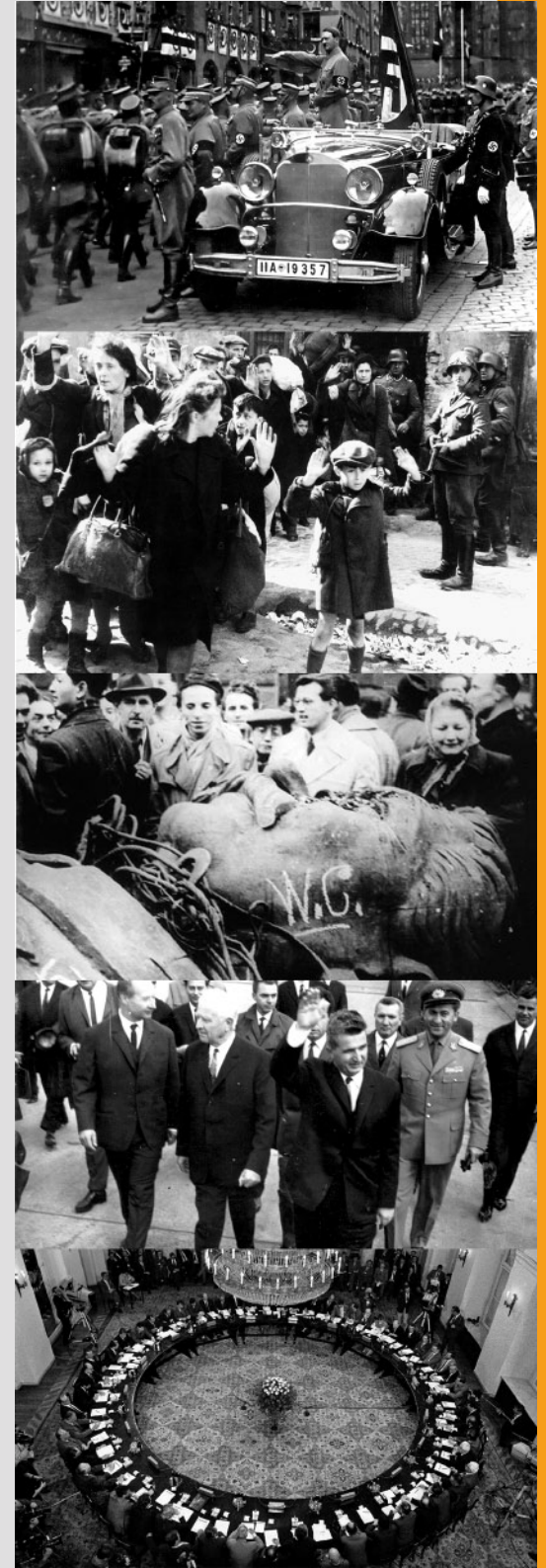

## } ABOUT EUROPEAN NETWORK “REMEMBRANCE AND SOLIDARITY”



The *raison d'être* behind the European Network “Remembrance and Solidarity” is to examine, disseminate, and document knowledge about the history of totalitarianism, dictatorships and wars in 20th-century Europe, accounting for their root causes, progress, acts of resistance, and consequences, however far-reaching. The foundation on which the Network operates is the effort to make sure that the historical message that it creates, supports and conveys is strongly rooted in the latest scientific findings, and that the formulation of the message contains no unjustified simplifications.

The task of the European Network “Remembrance and Solidarity” is to support the process of understanding the history of the 20th century through the multilateral exchange and discussion of historical facts and the various images of history. This is how the Network desires to establish a special tie between the nations of Europe, rooted in solidarity and based on a deeper reflection over the tragic and inspiring aspects of the history of the last century, yet also over those that fill us with sorrow and shame.

The European Network “Remembrance and Solidarity” pursues its goals in collaboration with international partners. In the case of some projects, the Network is both the architect and the main facilitator, while in the case of others, it supports partner institutions with know-how and finance. All the programme decisions are made by the international bodies of the Network.

The Network organises conferences, symposiums and scientific workshops, publishes scientific works, and commissions the translation of works that are material for becoming familiar with the aspects of 20th-century history described above that should be made known to the international reader. The scope of the Network’s duties also includes activities intended to disseminate knowledge of history among non-professional consumers and include exhibitions, co-production of films on history, organisation of reviews of such films, and creation of multimedia teaching aids and curricula for schools.

Declaration on the establishment of the Network was signed in 2005. The Network includes Germany, Hungary, Poland and Slovakia.

## } TOPICS OF INTEREST

“Remembrance and Solidarity” Review invites submissions of scholarly articles on the history of Central and Eastern Europe in the twentieth century. Topics of interest for the above area include, but are not limited to, the following:

totalitarian dictatorships  
war and resistance  
communistic repressions  
displacement  
nazi victims  
historical policy  
historical narration  
– schoolbooks, film, exhibition



Interested authors are encouraged to contact the editors in advance. All papers will be subject to peer-review before acceptance for publication. **The language of publication is native language and English. Texts will be translated and redact by English native speakers and published in 2 versions.** Articles must be sent electronically in Microsoft Word for Windows format, and submitted as email attachments in 12 pt. Times Roman font, one and half-spaced.



The editors of “Remembrance and Solidarity” Review invite the submission of original research articles, research notes, review essays, book reviews, conference reports, proceedings and historical sources.



## } SUBMITTED MANUSCRIPTS SHOULD CONTAIN:

a cover page with a title and a short abstracts in English, German or Russian language;  
a separate page with name(s) and affiliation(s) of the author(s);  
the main text with endnotes in author's language;  
references.

## } SUBMISSION PROCESS

All submissions should be submitted by email to the editors: Once you have submitted your manuscript, the editors will contact you and acknowledge your submission. Each manuscript receives an initial internal screening by the editors determining its suitability for the journal. This is followed by an anonymous peer-review process at the end of which the editors will make a decision about your manuscript.

The review process normally takes approximately 8-10 weeks, but can occasionally exceed this time frame. The editors endeavour to reach an informed decision quickly and to keep you up-to-date about the status of your manuscript.



## } STYLE GUIDE

The cover page should contain the title and a short abstract of around 100 words. The abstract should be clear and informative, giving an indication of the scope of, and results contained in, the paper. A separate sheet should give the name(s) and affiliation(s) of the author(s).

The main text with endnotes. All notes should be numbered sequentially and appear as endnotes. They should be referred to in the text by superscripts 1, 2, 3 etc. The notes themselves should be gathered together at the end of the manuscript before the references section.

References should be cited in the text by giving the last name of the author(s) followed by the year of publication in parentheses, e.g. Smith & Jones (2003); (Smith 2001a, 2001b).

The full references must be listed on a separate sheet at the end of the manuscript in the Harvard style. They should include all authors' names and initials, year of publication, title of article or book, the full title of the journal, volume and page numbers, and for books and other documents, the publisher's name and place of publication.
